





Custodian of the Policy


The implementation and updating of the research policy is carried out by the RDC members of University as per the UGC guidelines.

Objectives of Research Policy

13. The University is committed to promote the quality research in various programmes offered by the university at different levels







Code of Research Ethics and Integrity:

Makhanlal Chaturvedi University Bhopal hereby adopts the UGC Guidance Document on GOOD ACADEMIC RESEARCH PRACTICES (GARP) September 2020 for Code of Ethics for Research. Research Consultancy

Research consultancy of university will exist whenever any regular faculty of university delivers knowledge and Research/ professional skills in exchange for funds from external organization. Consultancy will be for sharing knowledge /Expertise /Skill /Production from university to external organizations and Business houses. University will encourage faculties for knowledge sharing in consultancy.

Under the consultancy policy university will take UGC guidelines for establishing **University -Industry Inter Linkage center** as per UGC guidelines,

1. To encourage original quality basic and applied research in the fields of mass communication, Computer science Library science and management.
2. To identify the emerging areas of research and encourage the faculty members to undertake research in these areas.
3. To establish linkage with media Houses and IT industries and business organizations to identify potential areas of Consultancy.
4. To acquire projects, market surveys/production /Applications and other research activities to acquire assistance from other business houses, industries, NGOs, boards and forums.
5. To encourage faculty members to get research consultancy from National Funding agencies like SERB, DBT, DST, ICSSR, UGC and other such institutions.
